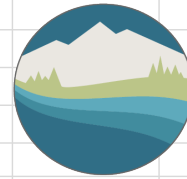

Section #5 Special Fees

Late charge an accounts not paid within 10 days of invoice date.	\$10.00
Turn on or off water service at customer's request.	\$10.00
Non payment shut-off door hanging fee. (This fee must be paid along with past due amount in order to avoid termination of water service).	\$25.00
Disconnection fee for non payment. (This fee must be paid along with the \$25 door hanging fee and the past due amount in order to reinstate water service.	\$45.00
Reinstallation of water meter for discontinued service.	\$50.00
Non sufficient funds check fee.	\$35.00
Credit/Debit card payment service fee.	\$1.50
ACH check processing fee.	\$0.50
Backflow device testing fee.	\$22.50
Backflow device re-testing fee.	\$22.50
